Anyway, I hope every Club is now enjoying a full caving calendar following a year of restrictions due to Foot and Mouth Disease.

The second lecture to cavers and the local community held in Crickhowell went very successfully with approximately 80 attendees. Our thanks to Eric Hoole, the Training Officer, who organised the event and the two speakers Martin Farr and Charles Bailey. The success of these two events means we will probably organise some more lectures, anyone with ideas for topics or locations please contact Eric or myself.

SUMMARY OF CCC AGM 2002

There was a last minute change of venue to the Hobby Horse Pub, Brynmawr, who very kindly allowed us to use a corner of their lounge bar even though it was Mothering Sunday, as our original location denied all knowledge of the booking I made. We were made very welcome and a map left at the original location meant everyone made it to the AGM.

- The meeting was quorate, with 12 member clubs/organisation represented.
- Cardiff University Caving Club was voted in as a full member, and a welcome back to this Club. A new group, Llanelli Caving Club have also joined CCC currently as a provisional member.
- Bob Mehew (NCA treasurer) came to the meeting to provide information on the proposals to form a single organisation for cavers and those involved related underground activities, commonly referred to as the one stop shop. The working name is 'Underground Britain'. The AGM supported the proposals to be made to the NCA AGM to move forward with setting up 'Underground Britain' organisation.
- The CCC constitutional changes and additions to the CCC policies were accepted by the meeting. This means CCC has now taken responsibility for the Cambrian Cave Registry. The policies provide the guidelines on how it will be organised and function.
- There is one change to the committee, Martin Peck now joins us as Equipment Officer.
- We have a new representative for Sports Council for Wales Outdoor Pursuits Group, this is Bridget Hall.
- The CCC subscription remains unchanged at £9, the meeting supported the increase to NCA subscription from £15 but this is for **2003 not 2002**. This years NCA subs remain at £12.

Finally, the AGM minutes will be sent out with the next Newsletter, I am still typing the minutes and compiling electronic versions of the officers' reports. The Cambrian Caving Council Constitution and Policies are included with this Newsletter, to save postage cost for the next Newsletter.

The NCA have had some problems maintaining their website in the last few months. A new Webmaster has been found but he has not yet gained access to the website to make changes. SUMMARY OF NCA AGM

The NCA AGM was held on 23rd March 02 in Alvechurch. There are a few changes to the Council members and assistants, these are: -

National Cave Register Co-ordinator - Dave Cooke, CSCC

The motions proposed and accepted were: -

Subscriptions:

Subscription to the NCA for 2003 will be £15 for clubs and £60 for Constituent Bodies

In addition to this, another proposal was brought to the meeting. This was (in outline) to agree that NCA would take on the role of providing insurance (BCRA are 'handing over') to caving clubs. The exact wording will be in the NCA AGM minutes to be circulated to member clubs.

National Body Structure:

1a accepts the principle of a "one stop shop"

1b accepts the document "UNDERGROUND BRITAIN" as the basis for detailed discussions with relevant parties for creating the "one stop shop"

2 instructs the secretary of the NCA to quickly initiate a postal ballot of all members in accordance with Clause 9.1 of the constitution, with the following question " Do you agree to NCA using the document "UNDERGROUND BRITAIN" as the basis for detailed negotiations with relevant parties to seek to create a "one stop shop" for all underground explorers;

3 instructs NCA Council to proceed on the basis of the results of that postal ballot: and

4 commends the document to all other relevant parties who need to come together to form the one stop shop as a basis for the discussion to achieve that aim.

Proposed by Wessex Caving Club

It is proposed that the NCA council should take such steps as necessary to introduce a form of individual membership to be voted upon at the 2003 AGM.

All the motions were accepted by the NCA AGM.



- Three cavers, Adrian Fawcett, Bob Hall, and Dave Appling attended an eco-anchor placement training in February. This means that we now have enough trained cavers to place anchors in the Cambrian region.
- It was agreed at the AGM, that Adrian with Bob Hall would complete eco-anchor placement in Pwll Dwfn.
- Martin Peck is the new Equipment Officer and will co-ordinate checks of the current P-hanger installations using the trained cavers. Any suggestions for placement of new P-hangers in Wales should be addressed to Martin. He will liase with interested parties to determine if P-hanger placement is appropriate. Placement of P-hangers in Forest of Dean is co-ordinated by FoDCCAG.

OVERSEAS EXPEDITIONS

The expeditions presentation evening organised by Sports Council for Wales at Cardiff in January had a good representation of cavers, including a number that applied for grants this year. The presentation included a talk by cave diver Martyn Farr.

I was a member of SCW overseas expedition grants panel this year. Amongst the 10 applications, there were 4 applications from Caving Expeditions, a very good percentage considering the number of different outdoor pursuits and the number of cavers in Wales. The four caving expeditions were: -

- An expedition to Belize
- A cave diving expedition to the Burren, Ireland
- An expedition to China
- An expedition to Dachstein, Austria

The panel agreed to all four caving expeditions receiving expedition grants from SCW. Factors we considered when determining the level of funding were the enhancement to the sport, uniqueness of the trip, the benefit to the local community being visited, benefits cost to participants and number of qualifying participants.

All the above prove that information on overseas expedition grants available from SCW is getting through to the cavers in Wales. Therefore, my thanks goes to the secretaries of the caving clubs who must be passing this information to their club members. My thanks must also go to SCW who keep me informed of grant funding available to cavers and our sport. As an aside SCW also provide sport safety grants for which Welsh Cave Rescue Teams are eligible, two of our teams have applied for funding this year.

GHAR PARAU FUNDING for OVERSEAS EXPEDITIONS

It was noted at the NCA AGM that there were only a small number of applications this year for Ghar Parau Awards.

It seems one of the reasons for lack of applications is the lack of knowledge about availability of funding. So if your Club is going on an overseas caving expedition don't forget there is funding available from Ghar Parau as well as for the Welsh Cavers funding available from Sports Council for Wales.
